## Overview

In support of strengthening student academic achievement, **Pioneer Middle School** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The plan establishes the district's expectations and objectives for meaningful parent and family involvement and describes how the district will implement a number of specific parent and family engagement activities.

The **Walla Walla School District** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

- Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement plan and the joint development of the schoolwide program plan under Section 1114(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended.     - that families play an integral role in assisting their child's learning;
    - that families are encouraged to be actively involved in their child's education at school;
    - that families are full partners in their child's education and are included, as appropriate, in decision making and on advisory committees to assist in the education of their child; and
    - the carrying out of other activities, such as those described in section 1116. [§8101(39)]

# Required Parent and Family Engagement Plan Components

### **Joint Development**

**Pioneer Middle School** will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Pioneer families will be involved in the development of the school parent and family engagement policy and be involved in the planning, review, and improvement of family engagement programs through opportunities like: fall & winter conferences, monthly Coffee with the Principal, school surveys, and an annual Center for Educational Effectiveness (CEE) survey when offered.

### **Annual Title I, Part A Meeting**

**Pioneer Middle School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I, Part A program, the nature of the Title I, Part A program, the parents' requirements, the school parent and family policy, the schoolwide plan, and the school-parent compact.

Pioneer will hold the Annual Title 1 information meeting to inform parents of the requirements of Title 1 and the school's participation as well as the parents' rights to be involved. ### Communications

**Pioneer Middle School** will take the following actions to provide parents of participating children the following:

- Timely information about Title I, Part A programs.
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parental involvement.
- A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards.
- If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.
- Information related to the school and parent and family member programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

Pioneer will distribute the family engagement plan to families in the fall through online formats, any larger scale school events if held this year, the Annual Title 1 meeting as well as the winter parent-teacher

conferences. A paper version will also be made available in the Pioneer office. The family engagement policy will be available in English and Spanish.

Pioneer also will provide communication to families about school-related activities, meetings, family engagement opportunities, and daily/weekly information through: Google Classroom, the school website, Coffee with the Principal monthly meetings, flyers, School Messenger, and teacher contact (email, status reports, texting apps like Remind, notes home, Zoom...).

### **School-Parent Compact**

**Pioneer Middle School** will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

### **Reservation of Funds**

The **Walla Walla School District** will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental and family engagement is spent.

Pioneer will provide workshops, conferences, classes, and online resources that support parents and family members in their student's academic success. Resources like: parenting workshops, the Title 1 winter parent conference in Pasco, District Wide ParentCamp in March, as well as other academic-based informational events/opportunities will be provided. Families will have the opportunity to make suggestions for other types of resources during the spring input meeting and through surveys.

### **Building Capacity of School Staff**

**Pioneer Middle School** will, with the assistance of its parents, educate its teachers, specialized instructional support personnel, principals, other school leaders, and other staff on how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents, and how to implement and coordinate parent programs and build ties between parents and schools.

Pioneer will provide workshops, conferences, classes, and online resources that support school staff to work with parents as equal partners. Resources like: parenting workshops, the Title 1 winter parent/teacher conference in Pasco, providing new teachers with the book <u>Powerful Partnerships</u>: <u>a Teacher's Guide to</u>

<u>Engaging Families for Student Success;</u> this resource also provides tutorial videos, and other online resources.

# Adoption

This school parent and family member engagement policy has been developed jointly and agreed on with parents of children participating in Title I, Part A programs, as evidenced by attendance from a Coffee with the Principal meeting to discuss survey results and funding.
