# Celebrations and Challenges as it Relates to District Outdoor & Athletic Facilities

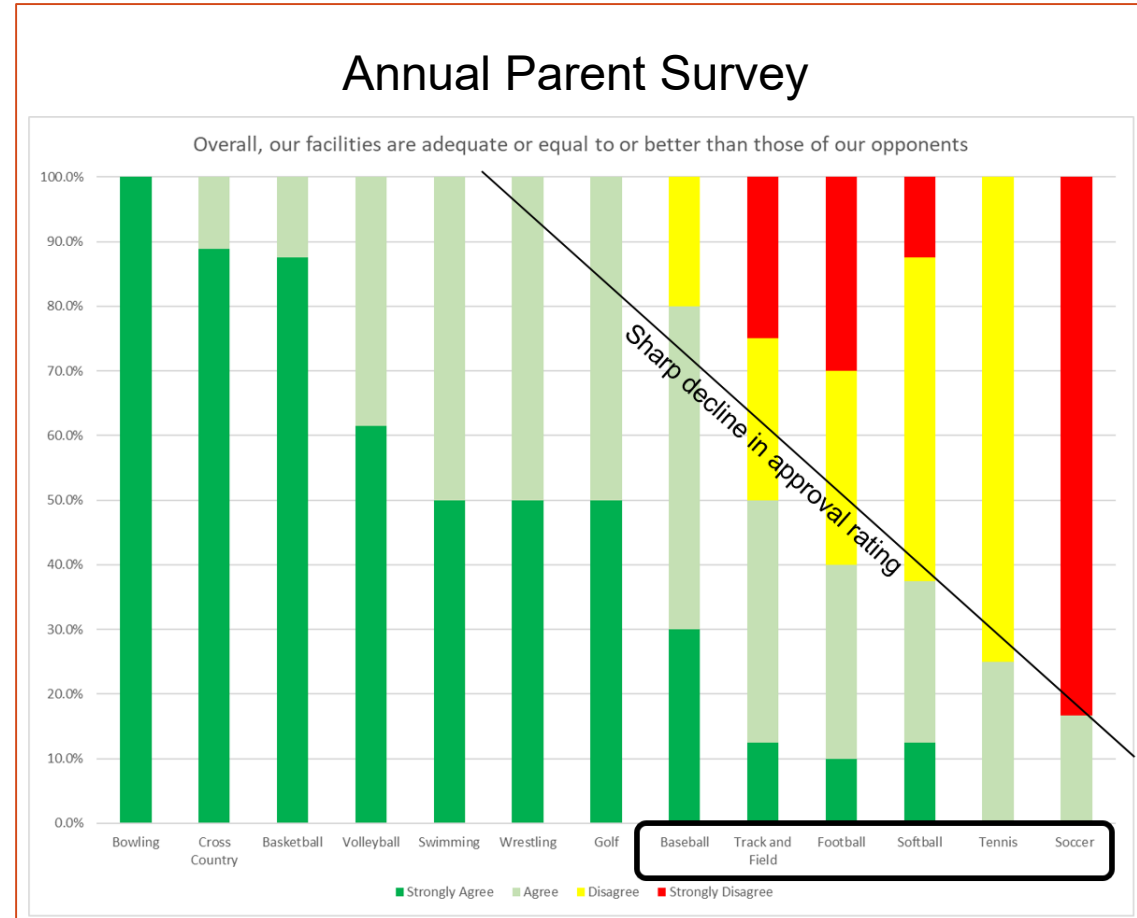
---

- The 2018 bond helped ensure classrooms, performing arts, fine arts, support areas and indoor extra-curricular spaces have all been brought up to current standards.
- As promised to voters, recent bond funds were not allocated towards any outdoor athletic or activity amenities or improvements.
- For many, many years, rather than asking for voter-approved bonds or levies to improve outdoor athletic facilities, WWPS has leveraged community donations, Booster Club support and basic ed maintenance dollars to try and keep up with extra-curricular facility improvements.
  - The district has invested over \$1.1M in basic ed dollars over the last four years alone trying to maintain/improve athletic facilities.
- Despite these efforts, WWPS' outside athletic and activity facilities have fallen significantly behind every school in the league. As a result, most of the district's exterior athletic components are in need of substantial renovations or improvements in order to maintain safe, adequate and comparable access.



# March 2023: Coaches & Parents Address the School Board

- Since 2019, WWPS coaches, advisors and staff have been meeting regularly to review current amenities, research league and regional facilities, review parent and athlete feedback and prioritize improvements necessary for student participants.



# Independent Athletic and Activity Community Advisory Group Formed

---

- 20-member Committee developed consisting of a broad cross section of parents, alumni, community and business leaders
- Convened 6 different times over the course of the spring to deeply research, review and deliberate the committee's charge:

“Walla Walla Public Schools requests the Committee to convene regularly to complete the work necessary to undergo the technical review and analysis in order to deliver long-term outdoor athletic and activity planning direction for administration.

The committee was tasked to deliver a final recommendation to the Superintendent no later than June 20, 2023. The recommendation will consist of capital improvement recommendations to outdoor athletic and activity facilities, accompanying cost estimates to perform the work, and potential funding mechanisms sufficient to address the list of improvements.”



# ATHLETIC & ACTIVITY FACILITIES REVIEW



## Community leaders team with district to find solutions to address aged outdoor athletic & activity facilities needs

Some of Walla Walla's most prominent business, community leaders, parent representative and alumni have stepped up to volunteer to serve on the district's Outdoor Athletic and Activity Facility Committee to work with the community to find solutions to improve the district's outdoor athletics and activities facilities. This spring the district is putting the finishing touches on the historic 2018 bond program which focused on indoor facilities needs and now the district is shifting its focus to outdoor spaces.

"As promised, our highly successful 2018 bond program focused on taking care of classrooms, science labs, performing arts, fine arts, and other indoor critical facility needs across the district, said Superintendent Dr. Wade Smith. "This is what our voters told us to focus on and that is exactly what we did. However, that does not mean the need to address outdoor amenities went away."

A comprehensive analysis of facility comparisons and

research has been performed of all district schools in the Mid-Columbia Conference (MCC). Committee members are reviewing this study, conducting additional research and prioritizing needs. They are also charged with identifying costs to make improvements, researching funding options and providing a recommendation to the school district.

# Highlights of Core Committee Charge

---

The committee's recommendation must include a thorough review of current outdoor athletic and activity facility amenities and conditions across the district's middle schools and high school campus, and:

1. Compare and contrast WWPS outdoor athletic and activity facilities to similar-sized schools in our athletic league/region
2. Research and report funding mechanisms utilized by league/regional schools
3. Provide pragmatic capital improvement solutions that attempt to deliver equitable and comparable outdoor athletic and activity facilities with similar-sized schools. In doing so, prioritize outdoor athletic and activity facility improvements considering the following criteria in the recommendation:
  - those that maximize student and spectator safety; those that are deemed most deficient from comparison schools; those that maximize student access, engagement and involvement; those that promote community and stakeholder access and use; those that address current and future programming needs; those that promote regional hosting of events, providing positive economic impact; and those that minimize instructional time loss for students

# Charge #1: Compare and contrast WWPS outdoor athletic and activity facilities to similar-sized schools in our athletic league/region

---

- The Committee performed deep analysis of all middle and high school programs across the league.
  - Richland (Hanford High School & Richland High School), Kennewick (Kamiakin High School, Kennewick High School & Southridge High School), Pasco (Pasco High School & Chiawana High School) and Hermiston High School.
  - Analyzed core facilities including Football, Tennis, Soccer, Baseball/Softball and Track amenities

# Charge #2: Research and report funding mechanisms utilized by league/regional schools

The primary funding mechanisms utilized by regional and league schools to make larger scale athletic improvements over the last two decades have been bond/levy funded improvements. The Committee found only one exception in Hermiston, where the Kennison Field Renovation Project was primarily paid for by grants, municipal donations and private fundraising in 2012

## Primary Funding:

- Kennewick:
  - 2019, 2015, and 2009 Bond/levies
- Richland:
  - 2017, 2013 and 2003 Bond/levies
- Pasco
  - 2023, 2017 and 2005 Bond/levies
- Hermiston
  - 2019 Bond, 2021 Fundraising and 2008 Bonds



# Committee's Unanimous Conclusion: Transition Away From Borleske

---

- While Borleske has served the district's needs for nearly a century (1926), the committee found it is long overdue to transition away from the facility in order to address a much needed **multi-sport/multi-use complex approach** - where football, soccer, track, marching band and other youth/community activities can access and participate year-round on an artificial turf field in order to maximize utilization and participation.
- Other Key Findings:
  - As Whitman and the Sweets continue to enhance the baseball field amenities, it becomes more problematic and prohibitive to convert the baseball stadium into a football field for 5 varsity games per year. **The use of Borleske costs the district \$100,000 per year in fees and associated costs (\$5,000 a football quarter).**
  - Whitman desires ownership of the complex in order to support baseball enhancements and further investments.
  - The locker rooms were condemned nearly 50 years ago so teams are forced to change in busses, batting cages and a small community meeting room.
  - The field is not accessible for practice or other athletic performances as such use would damage the grass for spring and summer baseball.
  - The spectator experience has become compromised as additional baseball safety enhancements are made.
  - Spectator restrooms, concessions and ADA access is limited.



# Charge #3: Provide pragmatic capital improvement solutions that attempt to deliver equitable and comparable outdoor athletic and activity facilities with similar-sized schools

---

## Committee Identified Priority Needs:

- Construct an adequate multi-purpose complex that complements the current Klicker track that can accommodate soccer, football, marching band, cheer/dance, lacrosse, PE, youth sports, permit year-around field utilization, and be sufficient to host playoff competition and events for regional schools
- Consistent with every school in our league, install artificial turf playing surfaces to maximize field utilization, participation and post season play
- Replace failing 60yr old original tennis courts at WaHi and relocate the new tennis/pickle ball courts to Murr Sports Park for improved community access
- Repair the 43yr old Garrison tennis courts (Chubb Courts) and resurface the 20yr old track
- Install an all-weather track at Pioneer for athlete, school and community access
- Consistent with all league schools, install low spill/low glare outdoor lighting for early evening play in order to minimize instructional loss and maximize family participation for baseball and softball players
- Provide adequate access to restrooms and locker rooms for high school athletes
- Construct a JROTC “raider course” for student, first responder and community use
- Ensure facility improvements support hosting of regional and community events for local economic impact

# Committee Deliberations

---

- We've Contemplated Three Different Models
  - “Extended, 2-phase Plan”
    - Relies on 2, 4-year levies to address core facility requirements that meet the minimum threshold of the committee's charge to deliver comparable facilities. Addresses the multi-sport complex first. All other improvements delayed until 2028-29 after 2<sup>nd</sup> levy approval.
  - “Comparable Plan”
    - Relies on a one-time, 38 cent short-term levy(6yr), to address core facility requirements that meet the minimum threshold of the committee's charge to deliver comparable facilities.
  - “Comprehensive Plan”
    - Relies on a one-time, 49 cent short-term levy(6yr), to address core facility requirements with additional enhancements.

# Committee Does Not Recommend the Extended 2-Phase Plan

- Drawbacks to the Extended 2-Phase Approach
  - Requires 2 consecutive levies and 8 years of tax collections
  - Delays most of the projects out until at least 2028-29
  - Inflation results in more expensive projects, costing taxpayers more
  - Results in phasing challenges

- Projects completed by fall 2026

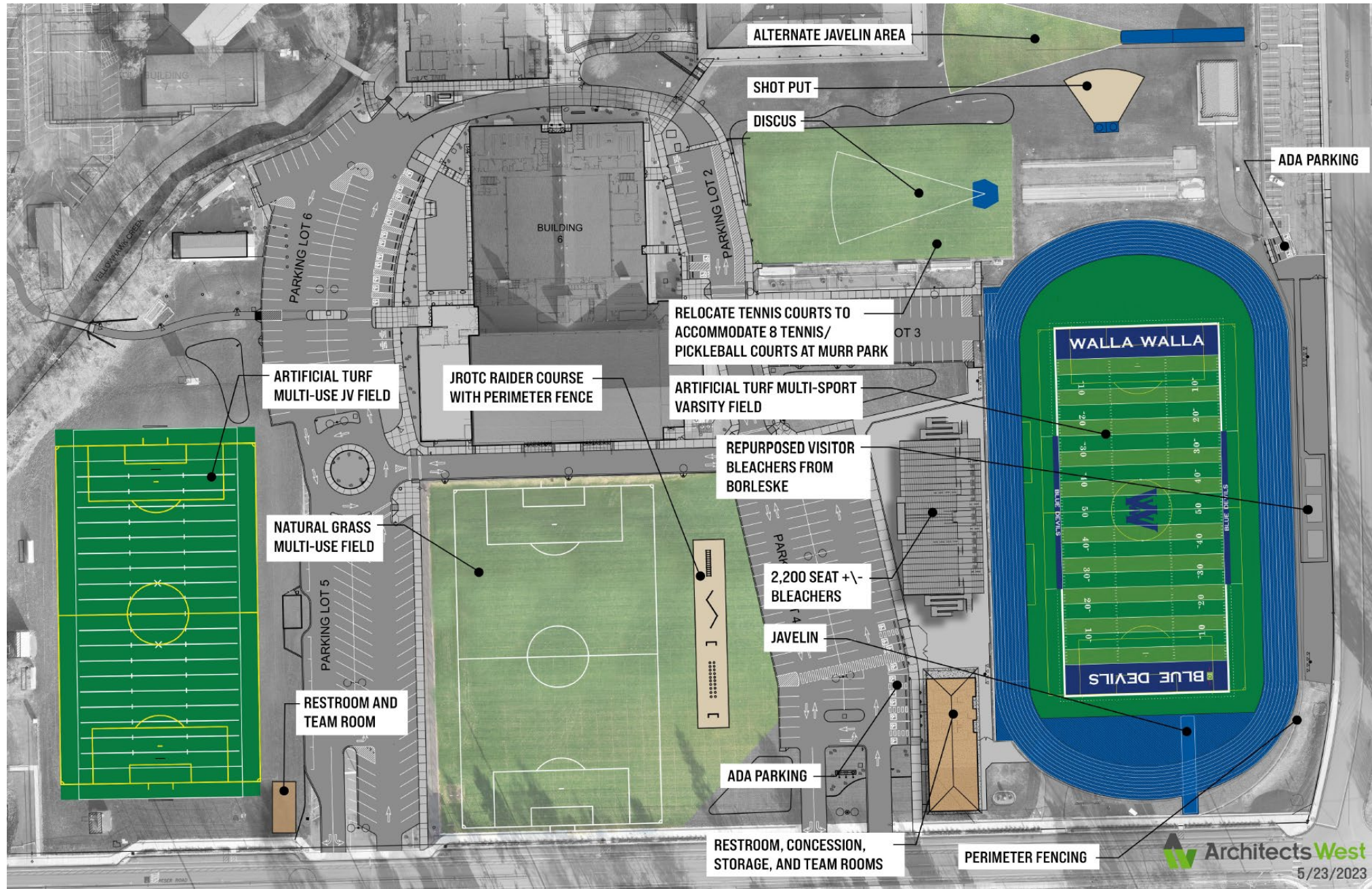

  - Multi-sport Complex
    - Includes 800 additional seating capacity in the multi-sport complex(3,000 seats on home side)
    - Larger announcers/press box (12X50) vs (8x24) with elevator access
    - Permanent structure under bleachers (Equipment Storage, Sports Med/Trainer Room & Gear Room)
  - Low spill/low glare field lights on JV multi-sport field
  - Replaces 55yr old west tennis courts at Garrison MS (Cobain Courts)

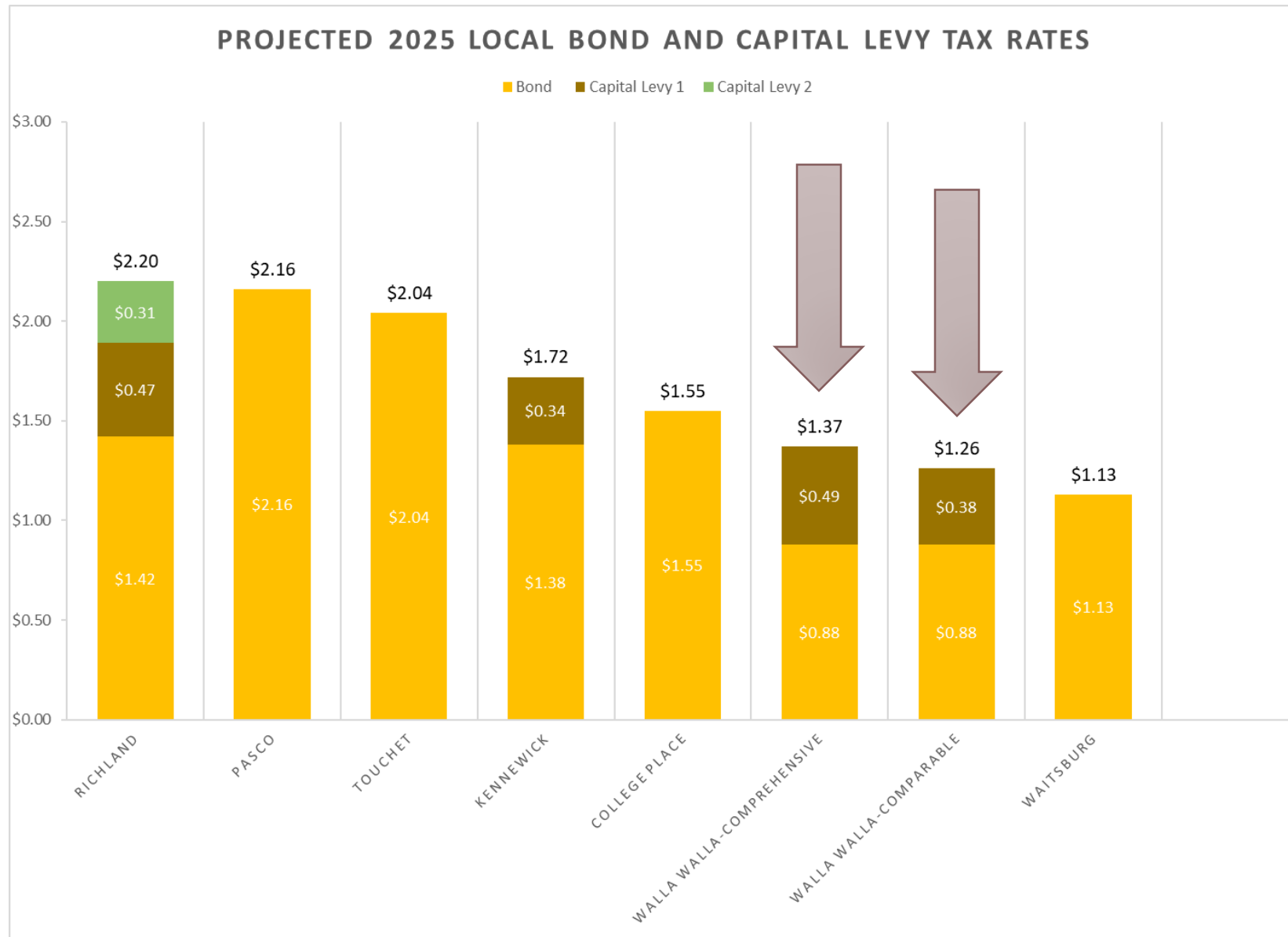
