AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Because public distribution of tests performed and the related results over information technology could increase the risk to the District's IT security, distribution of that information has been limited to management and the governing body of the District and is kept confidential under RCW 42.56.420.

About the audit

This report contains the results of our independent accountability audit of Walla Walla School District No. 140 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Basic enrollment reporting at the high school
- Associated Student Body expenditures
- Payroll - employee wages and leave cash outs
- Selected IT security policies and controls protecting financial data
- Tracking and monitoring of small and attractive assets

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes federal findings regarding the District's free and reduced lunch application verifications and suspension and debarment verifications for vendors reported. INFORMATION ABOUT THE DISTRICT

Walla Walla School District No. 140 provides a full range of school programs and services including elementary, middle school, high school, vocational education, bilingual education, special education, pupil transportation and food services. The District operates 10 schools and serves over 5,700 students in Walla Walla County.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent who is responsible for day-to-day operations and oversees its staff of approximately 440 certificated and 425 classified employees. The District had revenues of over \$76.6 million for the 2016-2017 school year.
