District ready for Symposium 2004

Communications Director **Mark Higgins** reported to school board members the district is ready for *Symposium 2004*.

Higgins said a group of nearly 100 community members, students, staff and parents will meet next Tuesday and Wednesday on the campus of Whitman College to discuss the future of Walla Walla Public Schools.

He said staff will receive e-mail copies later this week of the event agenda, information on facilitator Dr. Jim Parsley, a list of participants and an overview of the Symposium visioning process.

No Child Left Behind update

District schools avoid 'needs improvement' labels

"We have cause to celebrate," said Curriculum Director **Len Taruscio** to school board members during his annual *No Child Left Behind Act* Annual Yearly Progress report (AYP).

Taruscio said in his report no district school will be in year two of AYP "Alert" status, thus escaping punitive measures of the legislation for at least another year and labeling of needs improvement.

Last year, 17 of the 111 possible district "cells", or better described as categories such as race, gender, socio-economics, did not meet standard in grades 4, 7 and 10. This year only two cells fell short of AYP mandated targets. Despite the gains, the district will be in "needs improvement" status for these two areas and must craft an improvement plan to address these needs.

The two cells the district did not meet AYP in for the second year running are 4th grade Limited English Reading and graduation rate, which includes alternative programs students. Taruscio appealed the graduation rate hit because the district supports three successful Alternative programs. If progress is not made in these two cell areas next year, further punitive action will occur.

Taruscio said overall he is very pleased with the district's progress. He went on to say hard work from staff and students had the greatest impact on the improvement.

Each school and district must be assessed annually using the state's approved AYP criteria whether Title I funds are received or not.

Board approves request for mediation in Dohe case

School Board President **Tim Donaldson** approved a request from WEA's attorney to seek mediation in the Lori Dohe personnel matter. Donaldson appointed **Toni Rudnick** and **Dr. Rich Jacks** to be included on the district's team. This recommendation will now go to Dohe's attorney to see if it is accepted. Dohe, a Wa-Hi English teacher, was placed on administrative leave last school year.

In other School Board meeting business...

Board members:

- approved minutes of regular board meeting September, 2004, Personnel and Out-of-State travel reports; 2004-05 Negotiated Agreements: with PSE and Extracurricular Supervisors; payment of September bills and payroll.
- recommended surveying parents of Wa-Hi students to determine if **Friday, June 3** is their first choice for graduation. A scheduling conflict with spring sports state competitions is causing the concern. The majority of seniors surveyed voted for June 3.

Walla Walla Electric and Walla Walla Fire Department officials determined a light fixture ballast system caught fire. All other gym lights, which were replaced just two years ago, were inspected. Maintenance staff are studying options to the current lighting system.
