Safe Return to School

Preliminary plans for fall reopening include AM/PM option or all online

Last night Superintendent Dr. Wade Smith shared options for families as planning for safely reopening schools continues. He announced the district is seeking input from parents regarding which educational model best meets their families' needs as the district continues developing plans to safely and effectively reopen schools Sept. 8.

The 6-foot social distancing state mandate for all schools limits Walla Walla Public Schools' ability to serve its entire school population at the same time.

"If circumstances surrounding the virus allow the school district to safely provide in-school instruction in the fall, the district will be implementing an AM/PM model based on prior parent and stakeholder feedback," said Superintendent Smith. "Under this program, students attend approximately half their student day in-person on campus, Monday thru Friday, and half their day in a formal distance learning format from home."

He went on to say if by mid-August it is deemed not safe to reopen schools in September, the district will start off with Distance Learning 2.0 Contingency. Under this scenario, students will receive approximately half of their instruction in a synchronous online setting with their classroom teacher(s) [e.g. daily, scheduled classroom instruction over videoconferencing from their teacher(s)]. Students will complete their remaining instruction in a distance learning format from home. This will ensure an optimal learning experience while allowing the district the ability to efficiently transition to the AM/PM in-person model as soon as it is safe to do so.

Additionally, for those who are seeking a 100 percent digital online program regardless, the district is able to offer services through its new Walla Walla Online School.

This week the district launched another survey to seek parent requests for fall student enrollment. Responses are due by Sunday, July 26.

Superintendent Smith said safety and the wellbeing of staff, students and visitors is at the core of all decisions.

"Our district is following guidance from local, state and national health experts in developing comprehensive cleaning, screening, and protection protocols to ensure the safest learning experience possible," said Smith. "Routine classroom cleaning between AM/PM shifts and class periods, deep cleaning measures, hand sanitization supplies readily available, frequent handwashing practices and facility modifications have all been implemented to support the health and wellbeing of all."

School Resource Officer program review

School board members received a report from Superintendent Dr. Wade Smith and Walla Walla High School Principal Ron Higgins on the district's relationship with Walla Walla County for a School Resource Officer. The topic of school resource officers began to surface across the country in June prompting School Board President Sam Wells to request more information on the program. The district's School Resource Officer, a Walla Walla County Sheriff's Deputy, is stationed at Wa-Hi and primarily funded by Walla Walla Public Schools.

Last night's report included peer-reviewed research related to SRO's in schools, the local history of the program, current relationship with WW County Sheriff's Department, policies related to law enforcement and recent surveys related to the perception surrounding school safety.

The School Resource Officer program began in 2001 at Walla Walla High School with a partnership with Walla Walla County. The district also contracted with the City of Walla Walla Police Department from 2001-2015 for a school resource officer to provide support at nine campuses within city limits. This agreement ended after the city was unable to staff the position due to officer shortages. Walla Walla County also briefly suspended its relationship with the district during the 2015-2016 school year due to a shortage of deputies. The position was staffed the following year and continues today. The School Resource Officer supports traffic safety near the campus, emergency response calls, Incident Command Team functions during a crisis, investigations and safety support for after-school events. Annual survey results from staff, students and parents overwhelmingly reveal they feel safe on campus. No action was taken.

- AWI completed the permit drawings and submitted to the County and other entities for permits.
- All necessary letters and documentation were assembled and submitted for State matching funds.

Blue Ridge Elementary

- Wellens General Contractors continued to work on finishing the re-roofing activities.
- The storm water drainage systems were completed including the parking lot crossing and pouring back the removed pavement sections.
- Wellens initiated the installation of the revised irrigation systems.
- The building was pressure washed and soffits were repaired in preparation for painting of the entire building.
- Temporary fencing was removed as site work has been completed and heavy equipment has been removed from the site.
