# Miller's message to teachers: Thank You

Superintendent Mick Miller reminds teachers of the important role they have in our society and expressed his personal thank you for the work they do.

Miller's presentation was part of a college course nearly 40 area educators are taking this summer. Miller stressed the importance of building positive relationships with students and reaching out to learn their passions and dreams.

Miller said you never know when a connection will have lasting effects.

### District to apply for state energy efficiency grants

Walla Walla Public Schools is working with Quantum Engineering and Development, Inc. to apply for more than \$1 million in state energy efficiency grants.

The district's approach will be a three phase process over the next three months which could net nearly a 1.5 (state) to 1 (district) match.

Using this model, the district would receive \$0.91 in state grants and incentives for every \$1 of district funds invested. The proposed plan calls for \$2.5 million in total project costs of which approximately \$1 million would be funded through state grants.

Schools to see improvements include: Blue Ridge, Prospect Point, Pioneer, Berney, Garrison, Green Park, District Office, and Walla Walla High School. Grant applications will begin in August and continue through October.

# Bond refinancing to save taxpayers \$200,000

Walla Walla taxpayers stand to save \$200,000 thanks to the district refinancing \$3,000,000 in existing school bonds to a lower interest rate.

The district is working with bond experts to watch the market for the best time to lock in a new interest rate.

The district will not refinance unless it can guarantee a \$200,000 savings above and beyond all associated fees. The district hopes to close the sale of the bonds by September.
