**I. CALL TO ORDER**

The regular board meeting was called to order in the administration building Anne Golden Boardroom at 6:30 p.m. by President Dr. David Hampson.

**II. FLAG SALUTE**

The flag salute and pledge of allegiance was led by Mrs. Cindy Meyer, Board of Directors.

**III. ROLL CALL**

All board members were present.

**IV. APPROVAL OF AGENDA**

Mrs. Meyer moved and Mr. Sarley seconded approval of the agenda as presented; the motion carried unanimously.

## V. CONSENT AGENDA

Mr. Cummings introduced the following individuals who were in attendance: Site Directors William Hammond – Garrison, Martin Fortney – Pioneer, and Andrew Sayers – WaHi.

## VII. COMMUNICATIONS

Dr. Hampson shared a letter from the office of Head Start regarding inclement weather make up days. Mr. Smith shared a letter from Vance Norsworthy addressing attendance and how it relates to the district's strategic plan.

## VIII. CITIZENS' COMMENTS

Erick Dietrich addressed the board regarding healthy foods being included in school lunches; Kathryn Southwick-Hess thanked Superintendent Smith for his response to her concerns and shared her perspective related to how the district handled her request last year related to a guest she wanted to bring to WaHi's The Little Mermaid; Gene Gossett informed the board of the recently formed JROTC Boosters to help support WaHi's ROTC program as a 501(c)3 organization and summarized successes of recent JROTC graduates; and Keith Swanson invited the board to join Walla Walla Valley Education Association members on Saturday to march for education, applauded Andrew Sayers of WaHi's 21<sup>st</sup> Century Program for the great work he accomplishes with students, and noted not every student has the same experience with complicated situations.

**X. ACTION ITEMS**

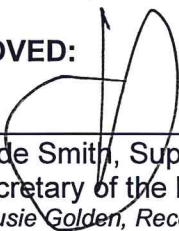
