Overview

In support of strengthening student academic achievement, Lincoln High School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement plan that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The plan establishes the district's expectations and objectives for meaningful parent and family involvement and describes how the district will implement a number of specific parent and family engagement activities.

The **Walla Walla School District** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

- Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement plan and the joint development of the schoolwide program plan under Section 1114(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. - Update the school parent and family member plan periodically to meet the changing needs of parents and the school, distribute it to the parents and family members of participating children, and make the parental involvement plan available to the local community. [§1118(b)(1)]

 - o Parent Involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—
 - that parents play an integral role in assisting their child's learning;
 - that parents are encouraged to be actively involved in their child's education at school;
 - that parents are full partners in their child's education and are included, as appropriate, in decision making and on advisory committees to assist in the education of their child; and
 - the carrying out of other activities, such as those described in section 1116. [§8101(39)]

Required Parent and Family Engagement Plan Components

Joint Development

Lincoln High School will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Lincoln families will be involved in the development of the school parent and family engagement plan and be involved in the planning, review, and improvement of family engagement programs through opportunities like: home visits, school surveys, and an annual Center for Educational Effectiveness (CEE) survey.

Annual Title I, Part A Meeting

Lincoln High School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I, Part A program, the nature of the Title I, Part A program, the parents' requirements, the school parent and family plan, the schoolwide plan, and the school-parent compact.

Lincoln will hold the Annual Title 1 meeting in the fall to inform parents of the requirements of Title 1 and the school's participation as well as the parents' rights to be involved. This meeting will be held virtually this year.

Communications

Lincoln High School will take the following actions to provide parents of participating children the following:

- Timely information about Title I, Part A programs.
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parental involvement.

- Information related to the school and parent and family member programs, meetings, and other
 activities, is sent to the parents of participating children in an understandable and uniform format,
 including alternative formats upon request and, to the extent practicable, in a language the parents can
 understand.

Lincoln will distribute the family engagement plan to families in the fall through the Annual Title 1 meeting and through scheduled home visits. An electronic version of the plan will also be available on the Lincoln website at www.wallawallalincolnhs.org. A paper version will also be made available in the Lincoln office. The family engagement plan will be available in English and Spanish.

Lincoln also will provide communication to families about school-related activities, meetings, family engagement opportunities, and daily/weekly information through: the school website, flyers, School Messenger, and teacher contact (email, status reports, texting apps, notes home, phone calls, etc).

School-Parent Compact

Lincoln High School will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

Reservation of Funds

The **Walla Walla School District** will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental and family engagement is spent.

Lincoln will involve parents in the decision-making about how the 1% reservation of Title 1, Part A funds are spent through: home visits, and school surveys that provides input into the family engagement plan and the school compact.

Coordination

- Providing assistance to parents of participating children, as appropriate, in understanding such topics as the following:
 - o The challenging State academic standards.
 - The State and local academic assessments.
 - o The requirements of Title I, Part A.
 - How to monitor a child's progress.
 - o How to work with educators to improve the achievement of their children.

Lincoln will provide workshops, conferences, classes, and online resources that support parents and family members in their student's academic success. Resources like: parenting workshops, the Title 1 winter parent conference, and other academic-based informational events/opportunities will be provided as needed. Families will have the opportunity to make suggestions for other types of resources during home visits and through surveys.

Building Capacity of School Staff

Lincoln High School will, with the assistance of its parents, educate its teachers, specialized instructional support personnel, principals, other school leaders, and other staff on how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents, and how to implement and coordinate parent programs and build ties between parents and schools.

Lincoln will provide workshops, conferences, classes, and online resources that support school staff to work with parents as equal partners. Resources like: parenting workshops, the Title 1 winter parent/teacher conference, providing new teachers with the book <u>Powerful Partnerships</u>: a <u>Teacher's Guide to Engaging Families for Student Success</u>; this resource also provides tutorial videos, and other online resources.

Adoption

This school parent and family member engagement plan has been developed jointly and agreed on with parents of children participating in Title I, Part A programs, as evidenced by comment cards from the August 2019 home visits.

This plan was adopted by Lincoln High School on September 30, 2020 and will be in effect for the period of School Year 2020-2021. The school will distribute this plan to all parents of participating Title I, Part A children on or before October 2020.
