## Overview

In support of strengthening student academic achievement, **Berney** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The policy establishes the district's expectations and objectives for meaningful parent and family involvement and describes how the district will implement a number of specific parent and family engagement activities.

The **Walla Walla Public Schools** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

- Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan under Section 1114(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. [§1118(c)(3)]
- Update the school parent and family member policy periodically to meet the changing needs of parents and the school, distribute it to the parents and family members of participating children, and make the parental involvement policy available to the local community. [§1118(b)(1)]
- In carrying out the parent and family engagement requirements of this part, local educational agencies and schools, to the extent practicable, shall provide opportunities for the informed participation of parents and family members (including parents and family members who have limited English proficiency, parents and family members with disabilities, and parents and family members of migratory children), including providing information and school reports required under Section 1111 of the ESEA, as amended, in a format and, to the extent practicable, in a language such parents understand. - If the schoolwide program plan under Section 1114(b)(2) of the ESEA, as amended, is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district. [§1118(c)(5)]
- The school district will be governed by the following definition of parental involvement and expects that its Title I, Part A schools will carry out programs, activities, and procedures in accordance with this definition:
  - Parent Involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—
    - that parents play an integral role in assisting their child's learning;
    - that parents are encouraged to be actively involved in their child's education at school;
    - that parents are full partners in their child's education and are included, as appropriate, in decision making and on advisory committees to assist in the education of their child; and
    - the carrying out of other activities, such as those described in section 1116. [§8101(39)]

## Required Parent and Family Engagement Policy Components

### Joint Development

**Berney** will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

*Berney families will be involved in the development of the school parent and family engagement policy and be involved in the planning, review, and improvement of family engagement programs through opportunities like: the fall & winter conferences, participation in the Parent Teacher Association (PTA), school surveys, and the Center for Educational Effectiveness (CEE) survey when given.*

### Annual Title I, Part A Meeting

**Berney** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I, Part A program, the nature of the Title I, Part A program, the parents' requirements, the school parent and family policy, the schoolwide plan, and the school-parent compact.

*Berney will hold an Annual Title 1 meeting to inform parents of the requirements of Title 1 and the school's participation as well as the parents' rights to be involved. ### Communications

**Berney** will take the following actions to provide parents of participating children the following:

- Timely information about Title I, Part A programs.
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parental involvement.
- A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards.
- If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.
- Information related to the school and parent and family member programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

*Berney will distribute the family engagement policy to families through the Annual Title 1 meeting as well as through larger scale school events and the winter parent-teacher conferences. An electronic version of the policy will also be available on the Berney website at*

Berney also will provide communication to families about school related activities, meetings, family engagement opportunities, and daily/weekly information through: Google Classroom, Class Dojo, Remind, the school website, newsletters, flyers, and teacher contact (email, status reports, texting apps, notes home, school messenger, social media...).

### **School-Parent Compact**

**Berney** will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

### **Reservation of Funds**

The **Walla Walla Public Schools** will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental and family engagement is spent. *(Only applicable to districts with an allocation of \$500,000 or more.)*

- Funds reserved under this section by the district agency shall be used to carry out activities and strategies consistent with the district's parent and family engagement policy, including not less than 1 of the following:

*Berney will involve parents in the decision-making about how the 1% reservation of Title 1, Part A funds are spent through: school surveys, PTA, an annual meeting that provides input into the family engagement policy and the school compact.*

## Coordination

- Providing parents and family members materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parental involvement
- Providing assistance to parents of participating children, as appropriate, in understanding such topics as the following:
  - The challenging State academic standards.
  - The State and local academic assessments.
  - The requirements of Title I, Part A.
  - How to monitor a child's progress.
  - How to work with educators to improve the achievement of their children.

*Berney will provide workshops, conferences, classes, and online resources that support parents and family members in their student's academic success. Resources like: parenting workshops, the Title 1 winter parent conference, ReadyRosie online family engagement tool, as well as other academic based informational events/opportunities will be provided. Families will have the opportunity to make suggestions for other types of resources during the annual input meeting, through surveys and PTA.*

## Building Capacity of School Staff

**Berney** will, with the assistance of its parents, educate its teachers, specialized instructional support personnel, principals, other school leaders, and other staff on how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents, and how to implement and coordinate parent programs and build ties between parents and schools.

*Berney will provide workshops, conferences, classes, and online resources that support school staff to work with parents as equal partners. Resources like: parenting workshops, the Title 1 winter parent conference, ReadyRosie professional development around partnering with parents, providing new teachers with the book Powerful Partnerships: a Teacher's Guide to Engaging Families for Student Success; this resource also provides tutorial videos, and other online resources.*

## Adoption

This school parent and family member engagement policy has been developed jointly and agreed on with parents of children participating in Title I, Part A programs, as evidenced by the PTA attendance for the December 8th meeting.

This policy was adopted by the **Berney** on January **12, 2021** and will be in effect for the period of **School Year 2020-2021**. The school district will distribute this policy to all parents of participating Title I, Part A children on or before **January 22, 2021**.
