Description of Boundaries - Beginning at the northeast corner of Section 6, Township 8 north, Range 37 E.W.M.; running thence southerly 2 miles; thence easterly 1/2 mile; thence southerly 2 miles; thence westerly 1-1/2 miles; thence southerly 2-1/2 miles to the southwest corner of the northwest quarter of Section 6, Township 7 north, Range 37 E.W.M.; thence easterly 2 miles; thence southerly 2 miles; thence easterly 1 mile; thence southerly 1/2 mile; thence easterly 5 miles to the northeast corner of Section 20, Township 7 north, Range 38 E.W.M.; thence southerly 3/4 mile; thence easterly 1 mile; thence southerly 1/4 mile, thence easterly 3 miles to the northeast corner of Section 25, Township 7 north, Range 38 E.W.M., thence southerly 4-1/4 miles, more or less to the Washington-Oregon state line; thence westerly along said state line a distance of 18 miles, more or less, to the southwest corner of the northwest quarter of Section 18, Township 6 north, Range 36 E.W.M., thence northerly 2-1/4 miles, more or less, to the northwest corner of Section 6, Township 6 north, Range 36 E.W.M.; thence northerly on the west line of said Section 31 to the west line of the U.S. Military Reserve; thence northwesterly along the west line of the U.S. Military Reserve to the north line thereof; thence northeasterly along the north line of the U.S. Military Reserve to its intersection with the east and west centerline of Section 25, Township 7 north, Range 35 E.W.M.; thence westerly along the east and west centerline of said Section 25, a distance of 350 feet, more or less; thence northerly 1/2 mile, thence westerly 3,313.5 feet more or less to the southwest corner of Section 24, Township 7 north, Range 35 E.W.M.; thence northerly 1 mile, thence westerly 2 miles; thence southerly 1 mile; thence westerly 1-1/2 miles to the northeast corner of the northwest quarter of Section 29, Township 7 north, Range 35 E.W.M.; thence southerly to the north right-of-way line of U.S. Highway #12; thence northeasterly along the said right-of-way to its intersection with the east line of the southwest quarter of the southeast quarter of said Section 29; thence southerly along said east line of the southwest quarter of the southeast quarter of Section 29 to the south line of said Section 29; thence westerly 1/4 mile; thence southerly 382.0 feet to the north line of the Whitman Donation Claim; thence easterly to the northeast corner of said Claim; thence southerly to the north line of the O.W.R.R. & N. Company's right-of-way; thence southwesterly along said right-of-way to the west line of Section 32, Township 7 north, Range 35 E.W.M.; thence southerly to the southeast corner of Section 31, Township 7 north, Range 35 E.W.M.; thence westerly 1 mile, thence southerly 1/2 mile to the east and west centerline of Section 1, Township 6 north, range 34 E.W.M.; thence westerly along the east and west centerline of Section 1 and 2, a distance of 2 miles, thence southerly 1-1/2 miles to the southeast corner of Section 10; thence westerly 1 mile; thence southerly 1/4 mile, more or less, to the Washington-Oregon state line; thence westerly along said state line a distance of 1 mile; thence northerly 4-1/4 miles, more or less, to the southeast corner of Section 20, Township 7 north, Range 34 E.W.M.; thence easterly 1 mile to the southeast corner of Section 21, Township 7 north, Range 34 E.W.M.; thence northerly 10 miles, to the northeast corner of Section 4, Township 8 north, Range 34 E.W.M.; thence westerly 1-1/4 miles; thence northerly 1 mile; thence westerly 3/4 mile; thence northerly 1 mile; thence easterly 1 mile; thence northerly 1 mile; thence easterly 2 miles to the northeast corner of Section 22, Township 9 north, Range 34 E.W.M.; thence southerly 3 miles to the southeast corner of Section 34, Township 9 north, Range 34 E.W.M.; thence easterly 15 miles more or less to the point of beginning.
